
Whereas, this office in compliance with the Hon'ble High Court directions passed in SWP No. 2416/2012 dated 03.09.2014 and the judgement upheld by the Division Bench in LPA (SWP) No. 149/2014 dated 11-11-2014 issued the tentative seniority list of J&K Forest Protection Force Inspectors (Except the petitioners in SWP No. 26/2015, SWP No. 11/2015, SWP. No. 326/2015 and 1092/2016) on the basis of the merit obtained at the end of the Initial Training Course vide Order No. 458 DFPF of 2016 dated **29-04-2016**.

Whereas, the objections were sought from the incumbents regarding their placement in the seniority list.

Whereas, the objections thus received by this office were examined by the committee constituted vide this office Order No. 576 DFPF of 2016 dated 22-06-2016 in light of the applicable rules. The objections which were found genuine were accordingly considered and rest of the objections which were without merit were rejected in view of the recommendations made by the committee.


