The appointment of the appointee shall further be subject to the following conditions: -

- a) That She will give an undertaking in the shape of an affidavit duly attested by the Judicial Magistrate, 1st Class to the effect that if on verification, genuineness of the qualification certificates of the concerned issuing authority is found fake/forged, the claim of the appointee for appointment as Orderly (Multitasking Staff) shall also be deemed to have been cancelled ab-initio and the legal action as warranted under rules shall be initiated against the applicant.
- b) The salary of the appointee shall not be drawn and disbursed to her unless a satisfactory report in respect (a) above is received in her favour.
- c) The appointment of the candidate shall be governed by the New Pension Scheme as per SRO-400 of 2009 dated 24-12-2009.
