

## Headquarters Forest Protection Force, J&K.

Subject: Tentative Seniority of Forest Protection Force Inspectors.

Order No. 458 DFPF of 2016

Dated: 29-04-2016

Whereas, the department issued the Division wise final seniority lists as per the merit obtained in Selection of SSRB of Forest Protection Force Inspectors of Kashmir region vide Order No. 14 DFPF of 2011 on 20-01-2011 and of Jammu region vide Order No. 01 DFPF of 2012 on 02-01-2012 as per Classification, Control and Appeal Rules, 1956.

Whereas, the Forest Protection Force Rules, 2012 were notified vide SRO-264 of

2014 dated 09-08-2012.

Whereas, after the notification of SRO-264 of 2012 number of service writ petitions were filed in the Hon'ble High Court at Jammu as well as in Kashmir for maintaining the seniority lists as per rule 38 of SRO-264 of 2012.

Whereas, the Hon'ble High Court in SWP No. 1895 of 2012 clubbed with SWP No. 2416/2012 dated 03-09-2014 directed the respondents to re-draw the seniority as per SRO-264 and the judgement was upheld by the Division Bench in LPA(SW) No. 149/2014 dated 11-11-2014.

Whereas, in SWP No. 26/2015 titled Mohammad Numan Khan and others Vs State and others filed in Hon'ble High Court of J&K at Kashmir and also in couple of writ petitions bearing SWP No. 11/2015 and SWP No. 326/2015 filed in the Hon'ble High Court of J&K at Jammu the Hon'ble High Court ordered not to revise the seniority of petitioners.

Whereas, the Administrative department vide letter No. FST/Lit/FPF/236/2014 dated 19.11.2014 also asked this office to re-draw the seniority of Forest Protection Force

personnel as per SRO-264.

Whereas, the rule 38 (1) of it envisages that Candidates who are sent for initial training to a training school shall rank in seniority in the relevant grade, according to the order of merit obtained at the examination held at the end of training period before being posted against working posts and those who pass examination in the second attempt shall rank junior to those who passed in the first attempt but shall rank senior to those who pass in the next or subsequent batches and where candidates secure equal marks, the seniority shall be determined by the date of birth-the elder candidate being senior.

Now in view of the above, the tentative seniority list of Forest Protection Force Inspectors on State Cadre basis is annexed with this order as Annexure-'A' drawn on the basis of the merit obtained at the end of the Initial Training Course and the Seniority of the petitioners of SWP No. 26/2015, SWP No. 11/2015 and SWP No. 326/2015 shall be subject

to the outcome of the writ petition.

All the concerned are requested to represent within 21 days of the issuance of this order for any objection/correction regarding their name, serial number, etc. in the seniority list.
